## **Bank Reconciliation**

The Banking Reconciliation reports (RAPPRO) have been enhanced with new parameters to allow you to select the reconciliation date when launching the report. This saves you time by allowing you to easily re-print the report for a past date.

#### **VAT Framework**

Enhancements have been made to the VAT Framework including:

- VAT box codes are now available as a dedicated column in VAT reports. These are the:
  - Tax declaration on the debits
     & reprint
  - Tax declaration / collection & reprint
- You can now remove VAT box codes from the box description field
- A group of report can be associated to a VAT return when defining the VAT form. You can now do this by assigning a print code to a VAT form that will allow you to print several reports for the VAT return.

## **VAT Return Posting**

To make it easier for you to generate journal entries, the VAT posting feature on the VAT return has been enhanced. This will allow you to offset the total VAT amount calculated for each company through the VAT return extraction into the 'Tax to disburse' or 'tax credit' accounts.

#### **Period Closing**

You can now activate balance controls that are executed when closing one or a group of periods.

Please note: Controls are triggered by the parameter CTLCLOPER which will not be active by default. If the parameter is set to 'Yes', the controls are performed at the closing on each period. Dependent on the volume of data selected, it can increase the time required by the process. Please refer to the Sage X3 Online help center for more details.

The GST VAT return has been extended with an online submission option to allow you to generate a VAT form for online submission. This helps you to save time by generating files in pdf form and can be easily transmissible online.

The Making Tax Digital header has been updated to include the anti-fraud information required by the HMRC.

#### **ATCUD Management**

To help you meet Portuguese requirements, the series generation and ATCUD code link is now managed in the 'ATCUD management' function.

You can now validate and print the ATCUD code in all relevant documents.

## **QR Codes in reports and SAF-T documents**

To comply with local legislation, you can now add a QR code to all relevant documents and reports, you have the option to add the QR code to the first or last page.

## Spain

#### Forms 180, 347 & 390

To help you comply with Spanish Tax Authority requirements, you no longer need an external application when generating the required declaration forms.



Note:

- Form 347: Information Return. Annual information return on transactions with third parties
- Form 180: Withholdings and payment on account. Income from urban building leasing. Annual summary
- Form 390: Value Added Tax. Annual summary tax return.

#### Mini One-Stop Shop (MOSS)

For ease of use, you can now register your business using MOSS instead of registering in each EU member country where you do business. You can also submit your VAT returns with a single EU member registration.

You can now:

- Record notes when testing a design revision/ testing the prototype to a revision
- Create a separate Production BOM for each revision of a design product, enabling your design engineers to test different revisions using separate production BOM in a prototype work order.

- Record a work order to create a prototype of the new design product which helps you to test the new design product revision and compare different prototypes to see if they meet the requirements of the new product.
- Track the production of a prototype product.
- When the approval phase has been successfully completed, the design product can be released and can be produced in multiple alternatives.

## **Trial Kitting**

The Sales Orders function has been enhanced by adding Trial kitting to the Ordered quantity field. You can use this functionality to assess future stock requirements or to find out whether there is sufficient stock to produce the requested quantity of the parent product.

Note: The Trial kitting action is only available for sales order lines where a BOM exists for the product.

## **Time Management**

Enhancements have been made to Time Management. You can now:

- Separate all grouped time entry lines into separate, individual lines.
- Currency rate and Remaining load update have been added to the Time summary table in the Weekly timesheet function.
- You can view and modify the Currency rate for a specific timesheet quantity.
- Analytical dimensions are now available in the Time entry detail screen.
- You can now further filter employee time records by Operating site.
